

# ClearPath MCP Express Non-Production Limited Unisys Software License Agreement

## 1. GRANT

Upon executing this ClearPath MCP Express Non-Production Limited Software License ("MCP EXPRESS"), UNISYS will grant you the right to obtain and use the MCP operating system and any associated documentation ("Licensed Software") upon a single computer system ("Licensed Computer"), providing that the use of the Licensed Software does not include or support COMMERCIAL or GOVERNMENTAL purposes, activities or applications. The grant of this MCP EXPRESS License is limited to non-production evaluation, personal or educational use ONLY. This MCP EXPRESS License is void if the Licensed Software is employed for developing applications for resale or public distribution.

You may copy the Licensed Software into a memory or storage device associated with the Licensed Computer. In addition, you are permitted to make a single archival or back-up copy of the Software.

This is a personal license for use. You may NOT transfer or assign your rights to use the Licensed Software, the Licensed Software itself, any archival or back-up copy of the Licensed Software or any accompanying documentation, including this MCP EXPRESS License agreement.

## 2. OWNERSHIP/COPYRIGHT/INTELLECTUAL PROPERTY RIGHTS

The Licensed Software is owned by UNISYS and UNISYS suppliers. The code and documentation are protected by copyright laws and international treaties. Various aspects of the operation of the Licensed Software are also protected under U.S. and Non-U.S. patents. NO OWNERSHIP RIGHTS are granted to you under this MCP EXPRESS License.

## 3. RESTRICTIONS

You may not copy, rent, lease, disclose or otherwise transfer the Licensed Software except as expressly authorized in this MCP EXPRESS License agreement.

You may not remove any copyright, trademark or other proprietary notices from the Licensed Software or from any media upon which the Licensed Software was provided.

You may not reverse engineer, decompile, or disassemble the Licensed Software, except to the extent permitted or ordered by law. Upon notice to Licensee, UNISYS may audit Licensee's use of the Licensed Software to determine Licensee's compliance with the MCP EXPRESS License.

## 4. TERMINATION

Your rights to use the Licensed Software TERMINATE on July 31, 2019. Any use of the Licensed Software thereafter is prohibited without express written permission from UNISYS.

UNISYS retains the right to unilaterally terminate this MCP EXPRESS License at any time, without prior notice to Licensee. This includes the right to invalidate or revoke any associated License Key.

Upon termination, Licensee agrees to immediately cease all use of the Licensed Software and to remove any and all copies of the Licensed Software from any computers, memory or storage devices and media under Licensee's control. Licensee further agrees to either surrender or destroy any copies of the Licensed Software and associated documentation if requested to do so by UNISYS.

TO THE GREATEST EXTENT PERMITTED BY APPLICABLE LAW, IN NO EVENT WILL UNISYS OR ITS SUPPLIERS BE LIABLE FOR ANY DAMAGES WHATSOEVER, INCLUDING, BUT NOT LIMITED TO LOSS OF OR DAMAGE TO DATA OR USE, LOST PROFITS, REVENUES OR SAVINGS OR ANY DIRECT, INCIDENTAL, INDIRECT, SPECIAL, PUNITIVE, EXEMPLARY OR CONSEQUENTIAL DAMAGES, ARISING OUT OF OR IN CONNECTION WITH THIS AGREEMENT OR THE USE OR PERFORMANCE OF THE LICENSED SOFTWARE, WHETHER IN AN ACTION UNDER CONTRACT OR TORT INCLUDING NEGLIGENCE, EVEN IF UNISYS KNEW OR SHOULD HAVE KNOWN OF THE POSSIBILITY OF SUCH DAMAGES. IN ANY EVENT, AND TO THE GREATEST EXTENT PERMITTED BY APPLICABLE LAW, UNISYS AND ITS SUPPLIERS MAXIMUM AGGREGATE LIABILITY ARISING UNDER THIS AGREEMENT WILL NOT EXCEED \$250.00 USD.
