



ClearPath OS 2200 Express Non-Production Limited Unisys Software License Agreement (050415v5-OS2200)

LICENSE TERMS

1. GRANT

Upon executing this ClearPath® OS 2200 Express Non-Production Limited Software License (“OS 2200 Express License”), UNISYS grants you the right to obtain and use the OS 2200 operating system, associated supporting emulation software, and any associated documentation and information (“Licensed Software”) upon a single computer system (“Licensed Computer”), provided that the use of the Licensed Software does not include or support COMMERCIAL or GOVERNMENTAL purposes, activities or applications. The grant of this OS 2200 Express License is limited to non-production evaluation, personal or educational use ONLY. This OS 2200 Express License is void if the Licensed Software is employed for developing applications for resale or for public distribution.

You may copy the Licensed Software into a memory or storage device associated with the Licensed Computer. In addition, you are permitted to make a single archival or back-up copy of the Software.

This is a personal license for use. You may NOT transfer or assign (i) your rights to use the Licensed Software, (ii) the Licensed Software, (iii) any copy of the Licensed Software, or (iv) this OS 2200 Express License agreement.

2. OWNERSHIP/COPYRIGHT/INTELLECTUAL PROPERTY RIGHTS

The Licensed Software is owned by UNISYS and UNISYS suppliers. The code and documentation are protected by copyright laws and international treaties. Various aspects of the operation of the Licensed Software are also protected under U.S. and Non-U.S. patents. NO OWNERSHIP RIGHTS are granted to you under this OS 2200 Express License.

3. RESTRICTIONS

You may not copy, rent, lease, or disclose the Licensed Software.

You may not remove any copyright, trademark or other proprietary notices from the Licensed Software or from any media upon which the Licensed Software was provided.

You may not reverse engineer, decompile, or disassemble the Licensed Software, except to the extent permitted or ordered by law. UNISYS retains the right to audit Licensee’s use of the OS 2200 Express Licensed Software at any time, without prior notice to Licensee, to determine Licensee’s compliance with the OS 2200 Express license terms

4. TERMINATION

Your rights to use the Licensed Software TERMINATE one year from license grant. Any use of the Licensed Software thereafter is prohibited without express written permission from UNISYS.

UNISYS may terminate this OS 2200 Express License at any time, unilaterally and without prior notice to Licensee. This includes the right to invalidate or revoke any associated license key.

Upon termination, Licensee shall immediately cease all use of the Licensed Software and to remove any and all copies of the Licensed Software from any computers, memory or storage devices and media under Licensee’s control.

Licensee shall either surrender or destroy any copies of the Licensed Software and associated documentation, if requested to do so by UNISYS at any time.

Prior to termination, Licensee may submit a written request to UNISYS, to OS2200.Express@Unisys.com, to renew this OS 2200 Express License. UNISYS is under no obligation to grant such a request, but if granted any such renewal will only be effective upon the acceptance of a new OS 2200 Express License agreement.
